Sir,

I am directed to refer to your letters no. AN-I/1341/3/Election-VI, dated 01.02.2016 and to state that in exercise of the power conferred on it by Article 324 of Constitution and Section 20B of the Representation of the People Act, 1951 the Election Commission hereby appoints 10 IDAS Officers (as per list enclosed) as Expenditure Observer for the General Elections to the Legislative Assemblies of Assam, West Bengal, Tamil Nadu, Kerala and Puducherry, 2016 announced by the Commission vide Press Note no. ECI/PN/16/2016, dated 4<sup>th</sup> March, 2016 (copy enclosed).The Commission has organized briefing meeting to all appointed Expenditure Observer at Ashoka Hotel, Chanakyapuri, New Delhi on 10.03.2016 as per schedule mentioned below.

- 2. Under Section 13CC of the Representation of the People Act, 1950 and Section 28A of the Representation of the People Act, 1951, they will be deemed to be on deputation to the Election Commission from now till the completion of election. Working as Observer of the Election Commission they will be under subject to the control, superintendence and discipline of the Election Commission for their duties performed as Observer.
- 3. As Observer of the Commission, they are entitled for TA/DA as admissible on tour. They will draw TA/DA from their Ministry/Department/Office.
