The undersigned is directed to inform that this Department held a meeting on 9.6.2015 to discuss the Judgement dated 5.3.2015 passed by the Hon'ble High Court of Delhi in the matter of W.P (C) No.3919/2014 titled Sambhavna Vs Union of India.

- 2. The Cadre Controlling Authorities were invited to attend the above meeting to find out the reasons for allocating vacancies for Persons with Disabilities in excess of 1% each for the categories viz. (i) hearing Impairment and (ii) Locomotor Disability or Cerebral Palsy in Civil Services Examination, 2014, as the vacancies for the other category i.e. 'blindness or low vision' were lower than those two categories.
- 3. During the meeting, it has been decided to confirm from the Cadre Controlling Authorities that separate 100 point reservation roster register for Persons with Disabilities is being maintained in accordance with Para 15 of OM No.36035/3/2004-Estt (Res) dated 29.12.2005 issued by this Department and the vacancies for Persons with Disabilities are being computed accordingly. The OM dated 29.12.2005 may be read with OM No.36035/4/2013-Estt (Res) dated (6.1.2015 vide which Para 15(i) of the OM dated 29.12.2005 was amended. Both the OMs are available in www.persmin.gov.in> DOPT>OMs &Orders> Establishment (Res)>Persons with Disabilities.

It is requested that necessary confirmation may kindly be provided at the earliest to enable this Department to implement the aforesaid Judgment dated 4.3.2015 passed by the Hon'ble High Court of Delhi.
