The Terms of References (TOR) of the Committee will be as under:

- Study the feasibility of providing for PCDA (AF) Dehradun a visibility of the AUDOLS module, used by the LAOs of the Air Force, for monitoring of work done by their sub offices (LAO Air Force and Jt. CDA Air Force Nagpur).
- To study the purpose and scope of audit, requirements of LAOs and PCDA (AF) for Higher Audit, Performance Audit, Super Review and Special Audit Requirements.
- The existing procedure of manual audit will be seen in a few Air Force Offices/Units and will be compared with e-Audit proposed to be done through the system at PCDA(AF) New Delhi.
- > To introduce and monitor the parallel run, identify inadequacies and go for improvement in module for e-audit.
- To organize training in consultation with IMMOLS Directorate to the staff of PCDA (Air Force), Dehradun and their sub-offices at regular intervals and ensuring the latest versions of the software are available to these offices.

The Committee will visit PCDA (AF) Dehradun to discuss relevant issues and take a view regarding parallel run. ACAS (Procurement) and Directorate of IMMOLS of Air HQrs would also be associated with during the Committee's visit to PCDA (AF) Dehradun.
