Revised Circular

Subject: Transfer/Posting of SAOs/AOs.

It has been decided by the Competent Authority to empower PCsDA/CsDA/PCA(Fys) to carry out rotation/transfer/posting of SAOs/AOs (including AO GEs/AO BRTFs) within their command/jurisdiction with immediate effect.

- 2. For carrying out placement of SAOs/AOs within their command/jurisdiction, a DAPB consisting of three IDAS officers may be constituted by the respective Pr. Controllers/Controllers. If three officers are not available under their command, officers may be opted from other command. The following guidelines may be adhered to by the committee/DAPB while carrying out transfer/posting of SAOs/AOs:-
- (i) Posting in the O/o AO GE, AO BRTF, AO CCE, AO EBW, AO WBM and assignment/sections dealing with third party payment in the main offices/sub-offices and other similar offices will not be for more than two tenure in AO/SAO grade.
- (ii) A cooling off period of 03 years between two such assignments where third party payment is involved, should be maintained.
- (iii) Such cases, where Pr. Controllers/Controllers are unable to fill up the vacancy of SAO/AO through their own manpower resources, may be referred to HQrs office for placement.
- (iv) Hqrs office important circular no. AN/XIII/13006/2A/Vol-XXII dated 21.08.2017 may also be adhered to while rotating of SAOs/AOs.

- 3. Transfer/posting in respect of SAO/AO would be carried out by HQrs office in following cases:-
 - (i) Inter-Command transfer/posting.
 - (ii) Foreign posting.
- (iii) Transfer/posting on repatriation from Hard/Tenure/Centrally Controlled stations, if choice station of individual falls outside the jurisdiction of the respective Pr. Controllers/Controllers.
 - (iv) Transfer/posting of SAOs/AOs posted in PIFA/IFA offices.
 - (v) Transfer/ Posting of AAOs on their promotion to AO grade.
- 4. As data base containing all information of SAOs/AOs are maintained by HQrs office centrally, information regarding all the posting/transfer carried out by Controllers within their command/jurisdiction shall be invariably intimated to HQrs office with complete profile for updating the data base.
- 5. This order supersedes all the orders issued on the subject by HQrs Office.
