Based on the recommendations of the DAPB, the Competent Authority has approved transfers of SAOs/AOs as indicated in Annexure 'A' to this letter. Accordingly, the officers may be relieved of their present duties immediately with directions to report their new office of posting.

- 2 Further, reference is invited to Annexure-I to this HQrs Office letter No. AN/II/2153/Attachment/Newly IFAs, dated 02.08.2022 wherein some of the SAOs/AOs. who were initially posted in newly created IFA Offices, have been temporarily attached to other DAD offices in the station/nearby station. Now, it has also been approved by the Competent Authority to restore the earlier posting orders in respect of the officers as indicated in Annexure 'B' to this letter. It is, therefore, requested that the SAOs/AOs may be relieved immediately from the office where they are presently attached with direction to report for duty at the office mentioned in Annexure 'B' to this letter.
- 3. The relief of the officers shall not be deferred on the ground that a representation has been submitted for change of place/office of posting or on the ground that the reliever has not reported/been posted. Arrangement for additional charge may be made by the PCDA/CDA concerned at their end.
