Following facts have been brought to the notice of DAPB in the case for request for cancellation of transfer of Ashok Kumar, SA/8329447 issued on account of station seniority from Allahabad to Lansdowne:

- (iii) Shri Ashok Kumar, SA was amongst the Station Seniority at Allahabad as reported by the PCDA (Pensions) Allahabad. He alongwith others were posted ex-Allahabad.
- (iv) His date of appointment is 6.10.1983 and was shown as posted at Allahabad since his date of appointment.
- (v) His earlier request sent by PCDA (P) Allahabad alongwith other cases, for cancellation of transfer to Lansdowne on account of domestic/family reasons, was not accepted by the CGDA's office.
- (vi) It has been brought out that Shri Ashok Kumar was promoted as Record Clerk (Group 'C') in the Department on 16.01.1995 and prior to this date he was serving as Group 'D'.
- (vii) As per the CGDA's circular letter 26.2.1983, while determining the station seniority of an individual, entire service rendered by him in Group 'D' needs to be excluded.
- (viii) It has been brought out that PCDA (P) while indicating date of station seniority in the case of Shri Ashok Kumar as 6.10.1983 has not taken into account the existing instructions of the CGDA contained in their circular dated 26.2.1983.

2. Keeping in view the above position the DAPB recommends that the transfer of Shri Ashok Kumar from Allahabad to Lansdowne may be considered for cancellation. Suitable remedial action needs to be taken in this regard so that such incidents do not occur again.


