Promotion to the grade of Principal Controller of Defence Accounts (Higher Administrative Grade) along with Transfer/posting in HAG of the Indian Defence Accounts Service.

Consequent upon the approval of promotion of the SAG officers, listed in Annexure 'A' to this letter, to the grade of Principal Controller of Defence Accounts of the Indian Defence Accounts Service (in the pay scale of Rs. 67000-79000/- (pre-revised) and Rs. 182200-224100 level-15 of 7th CPC pay matrix), it has been decided by the Competent Authority to post them in the offices as reflected against their names. The promotion is with immediate effect or from the date of assumption of charge, whichever is later. On assumption of charge, the officer (s) may be designated as PCDA/PIFA, as the case may be. Before assumption of charge on promotion by the officer (s), it may be ensured that no disciplinary/criminal case is pending against them.

The additional charge will be in addition to their own duties and till posting of a regular incumbent.

- 5. PAR of the officer(s) till date of relief from the present charge/post may be initiated immediately in SPARROW system under intimation to HQrs office.
