Subject: Promotion of Clerk to the Grade of Auditor

The Competent Authority has amended the Recruitment Rules for the post of Auditor with retrospective effect (i.e. from the date of notification of Principle Rules dated 15 Sept 2009 published vide SRO 22 on 26th Sept 2009) vide SRO No. 53 dated 11/08/2014, inserting Note 3 under Column 12 after Note 2 as below:

"The eligibility service for promotion to the grade of auditor shall continue to be eight years for persons holding the feeder post of Clerk –cum- typist on regular basis as on the 26^{th} day of September, 2009."

Accordingly, the Controllers are requested to convene a DPC to adjudicate those Clerks (including retiree etc., if any), who had earlier not been adjudicated and who have completed eight years of regular service in Clerk's Grade as mentioned below, for consideration of their promotion to the grade of Auditor on the basis of their ACRs/APARs for respective period.
