- As per SAS Rule 4, to be eligible for appearing in the Preliminary Test to SAS Part-I examination, a candidate must have put **two years service** as on the first of the month in which examination is held (including continuous temporary service) in any of the grade of Sr. Auditors/ Auditors/Clerks/Typists/DEOs/Stenographers/Hindi Translators and Librarians in the Department provided that candidate must have cleared probation period. Thus, due to rescheduling of examination, the cut of date for counting two years of service will **now be 1**<sup>st</sup> **June**, **2014**. The other conditions notified vide HQrs Office Most Important Circular dated 20<sup>th</sup> January, 2014 remains unchanged.
- 3. The additional list of candidates now eligible due to extension of cutoff date for counting two years of service may be prepared Centre-wise strictly according to the proforma enclosed vide our earlier circular dated 20<sup>th</sup> January, 2014 and dispatched by name to **Shri Ambarish Barman,Sr.Asst CGDA (Admin) latest by 31.03.2014 (MONDAY) positively.**

As the intervening time between SAS Part II Examination, May, 2014 and the Preliminary Examination (Test), June, 2014 is very limited, the last date for rendition of the details of additional candidates may be strictly adhered to and necessary action initiated immediately based on uploaded copy of circular on the website, without waiting for post copy.
