Sir,

I am directed to refer to this Ministry's letter No. 1(2)/2004/ D (Pay/Services) dated 6<sup>th</sup> October 2015, on the subject cited above and to say that the President is pleased to decide that the Dearness Allowance payable to Armed Forces Officers and Personnel Below Officer Rank, including Non-Combatants (Enrolled), shall be enhanced from the existing rate of 119% to 125% with effect from 1<sup>st</sup> January, 2016.

- 2. The provisions contained in paras 2, 4 and 5 of this Ministry's letter No. 1(2)/2004/D (Pay/Services) dated 25<sup>th</sup> September 2008 shall continue to be applicable while regulating Dearness Allowance under these orders.
