In addition, garden and other charges, as applicable shall also be recovered.

(a) So far as para 2 (a) is concerned these orders will be effective from 1st Jan 2013 and will remain in force till further orders. The rates revised under para 2 (b) & 2(c) would be effective from the date of promulgation of revised rates by the respective local CPWD &MES authorities as the case may be.

The rates of damage as above would be the rates to be charged from unauthorised occupants.
