It is clarified that as per Revised TA Rules issued vide Department of Expenditure's OM No. 19030/3/2008-E.IV dated 23.09.08, reimbursement of expenditure incurred on transportation of conveyance, as per eligibility laid down in para 4D of the Annexure to OM dated 23.09.08, is to be regulated in accordance with the rates prescribed vide para 4C to the Annexure of the said OM dated 23.09.08, as amended vide OM of even No dated 08.06.10 and 24.01.11.
