C. SO-in-C - A special Dispensation of taking ex-post-facto concurrence of their IFA is being given to SO-in-C only in cases of emergency break down and provision of communication during exercises. This special dispensation will be valid only for "hiring of trunk circuits" for restoration of operational communicational infrastructure under Schedule-18. In such situation, SO-in-C will hire the trunk circuits directly and will later send the case to PIFA (M), IHQ of MoD (Army) for according ex-post-facto concurrence.

Sub - Special Dispensation under Inherent Powers

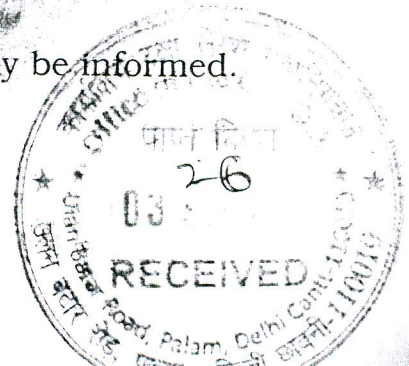
1. As per para 9 of Addendum-1A to DFPDS-2015, few CFAs will also get special dispensation of having powers upto Rs 1 lakh without IFA's concurrence. Though these CFAs do not qualify as per criteria mentioned in same para, yet they were to get special dispensation due to unique factors associated with them. This list was to be separately notified through a classified letter by MoD (Fin), in consultation with reps of CGDA and Air Hqs.
2. A list of such IAF CFAs granting them Inherent powers upto Rs 1 lakh was notified vide our letter dated 18.8.2015. Another list of 10 such IAF CFAs (inadvertently left out earlier) is enclosed for granting similar dispensation. As and when dedicated IFAs will be given to such CFAs, these Inherent powers given to them will be withdrawn.
3. In all cases of approvals without IFA concurrence, it will be ensured, after approval is accorded by CFAs, that a copy of sanction is invariably sent to concerned IFA for their record and reference in future procurements.
4. This issues with approval Of Raksha Mantri and concurrence of FA (DS).
