Provision of works under Para 35 of DWP, 2007-clarification-

Reg.

The case relating to clarification on processing of works under Para 35 of DWP in light of new Delegation of Financial Powers to Defence Services 2015 has been examined in consultation with MoD(Finance). In this connection, it is clarified that the whole procedure of delegation of Powers in respect of post contract management cases by DFPDS-2015 was to ensure timely execution of Para 35 of DWP very much falls in definition of post contract management. Therefore, powers vested in DFPDS-2015 are to be utilized for such activity.

- Therefore, all Para 35 cases where the time limit for obtaining the administrative approval of CFA before six months has also not been adhered to should be processed for regularization by the current CFA as per DFPDS-2015 and the current CFA may accord AA after thorough examination of the case(s) in consultation with IFA and satisfying himself with the reasons for invoking the provision of Para 35 of DWP 2007 by the Commander and the reasons for delay in initiating the case with subsequently prepared AEs by the Commander/Military Authorities.
- 3. Accordingly, all Para 35 cases may be processed for accord of Adm. approval by current CFA as per powers vested in DFPDS, 2015.
