Subject: Applicability of latest Delegated Financial Powers to procurement cases for which RFPs were issued under previous delegated financial powers.

The issue regarding applicability of latest delegation of financial powers to procurement cases for which RFPs were issued under previous delegated financial powers was considered in the Ministry. With the approval of the Raksha Mantri it has been decided that irrespective of the authority which approved the proposal in-principle or considered the case during the procurement process, the final sanctioning authority will be determined as per the present delegation of financial powers, i.e., the procurement proposal will be considered by the authority presently competent. Although the procurement process will be governed by the applicable DPM, under which the RFP was issued, the sanctioning authority would be determined by currently delegated financial powers.

In view of the above, para 2 of MOD Office Order-2015 No. Coord A-103 dated 2. 20/04/2015 (DFPM 2015) and para 2 of MOD Order No. 231 (9)/2016/B-II dated 06/09/2016 (DFPDS 2016) stand modified to this extent.
