Subject: Financial Advice Cases.

The financial advice cases as submitted by IFA, HQ, SWAC, Gandhinagar, Gujarat, is circulated herewith for information and guidance.

1. IFA (SWAC), Gandhinagar, Gujarat has carried out examination of the expenditure incurred by the units under SWAC AOR towards of purchase conventional Hot Weather Amenities as matter of routing during every summer season:-

All the units across Air Force are authorized to procure Hot Weather Appliance under OCG to provide conducive environment in the office against heat. This authorization letter is general in nature and its implementation regarding procurement of ibid items based on prevailing local conditions and keeping in view other infrastructure facilities available to offices and the stations. As an example, on detailed examination of HWA items procured at SWAC (U) in the HQrs SWAC, Gandhinagar in the last 03 financial years, it was noticed that the SWAC (U), Gandhinagar had been procuring conventional hot weather amenities like Matka, Surahi, Chetty, Mugs whereas it was fully equipped with modern summer appliances like Water Cooler, Water Dispenser and Camper i.e. Cool Kegs etc. The details of traditional hot weather amenities procured in the last three financial years are as tabled below:-

2012-13	107855
2013-14	111600

It was observed by the IFA(SWAC) Gandhinagar that there were various other items in this minor head like **Khas**, **Punkha Pullers**, **Tatties**, **Hand Fan etc**. Since these itmes are considered obsolete for day to day official purpose and instead modern age appliances (i.e Desert Cooler, Fan, Air Conditioning Machines etc) are being procured which are durable, easy to handle & easy; available in the market.

Similar is the situation in other AF Stations in Gujarat State. Though the amount involved in procurement of HWA appears meager, nevertheless, the spirit behind this advice came from the view that any infructuous / wasteful expenditure could be avoided and items of greater priority. Utility could be procured, instead.

2. IFA HQ (SWAC), Gandhinagar, Gujarat notified these facts to executive authorities at SWAC (Unit) of HQ SWAC, Gandhinagar and in this Financial Year i.e 2014-15 their office has not received any proposal on this subject from the SWAC (Unit), Gandhinagar. It was been mentioned that similar advisory action would also be taken in consultation with the local IFAs of the Unit/Formations under SWAC AOR after review of the existing conditions of those stations.
