

The matter of ban on procurement of vehicles has been examined in this Division and it is clarified that the supply of DGOF vehicles is qualitatively different from procurement ex-trade. While the latter is covered under the ban, the former is not, being in the nature of internal production from a dedicated in-house Government facility.
