

Subject:- Financial Advice Case.

The financial advice case of IFA HQ No. 03 Karnataka, (New Mangalore), is circulated herewith for information and guidance.

(1) Proposal for concluding Housekeeping and Catering contract.

IFA received a proposal for AON concurrence for outsourcing the Housekeeping and Catering service for Coast Guard Officers Mess. It was estimated that 23 personnel will be required to be deployed at an estimated cost of Rs 33.72 lakhs. After scrutiny of the proposal, IFA advised the executives to furnish details regarding visitors to the CGOM and revenue generated during the period. It was noticed from the record furnished by the Coast Guard authorities that the number of personnel taken into account to project the estimated cost of outsourcing contract was disproportionate to the requirement of the personnel such as number of visitors and area/rooms held under Officers Mess. IFA suggested to review the estimated cost of outsourcing contract. On the advice of the IFA, the requirement of outsourcing was reviewed and the estimated cost of outsourcing contract came down to the Rs 27.42 lacs from Rs 33.72 due to reduction in manpower requirement from 23 personnel to 19 personnel. It, therefore, resulted in savings to the tune of Rs 6.30 lacs.
